CONSULTATION: In order for me to properly photograph your wedding, I require that we have a final consultation one to two weeks prior to your wedding to review the wedding day schedule and final details.

EXCLUSIVE PHOTOGRAPHER: In order to eliminate confusion on the day of the wedding, it is understood that I am the exclusive photographer. Anyone else wishing to take still photographs will first consult with me, your photographer and abide by my judgment. It is the responsibility of the family and wedding party to enforce this should it become necessary.

PHOTOGRAPHY SCHEDULE: In order for us to complete your wedding portraits in a timely manner, it is absolutely necessary that everyone be ready at their pre-arranged times. This includes having your flowers ready and the church open and available for your portrait time.

ORDERS: Orders must be picked up within 30 days of being notified that they are ready, or a storage fee may be applied.

ORIGINALS: Original negatives are retained by the studio for 180 days. Any additional prints desired after the initial print order can be selected within those 180 days. A \$25 reorder fee will be applied to each subsequent order placed. Subsequent orders must be picked up within 30 days of being notified that they are ready, or a storage fee may be applied.

ALBUMS: The selected printed proofs for any albums ordered must be returned within 60 days in order to receive the album. If the proofs are not returned within 60 days, a non-refundable holding fee of \$30 will be charged. After 90 days the album order will be cancelled.

ACCOUNTS: Payment of any product orders or additional print orders is due when the order is placed. Orders will not be placed with the lab until all orders are paid in full.

BOOKING FEE: \$100 deposit required to hold wedding date and time.

REFUND POLICY: In the event of postponement or cancellation of the wedding, the booking fee (deposit) is non-refundable. If a change of date takes place and the studio is available, the booking fee (deposit) will be applied to the reschedule date. Should the reschedule date be postponed or cancelled the booking fee (deposit) is non-refundable and will not be applied to any additional reschedule dates.

STUDIO LIABILITY: This studio takes the utmost care with regards to exposure, development and delivery of photographs. However, in the event the studio fails to comply with the terms of this contract, the studio liability is limited to the refund of monies collected.

COPYRIGHT & ADVERTISING RIGHTS: Digital images will remain the exclusive property of this studio. It is agreed that rights to exclusive use of digital material reproduced by the high resolution files you purchase also constitute copyright and such rights are reserved by the studio in regards to display, publication, competition, sale, advertising, or other purposes.
